

## MESSAGE FROM THE BOARD

The Board is pleased to report that 2004 was a very good year for your Estacada Community Foundation.

The Estacada Community Foundation (ECF) is your local charitable organization that administers an endowment fund. These monies entrusted to us have been prudently invested and earnings on these investments, together with certain donations, are granted to local organizations in grants. The vision of the Foundation is to build a \$3 million permanent endowment. This would enable us to invest substantially in our community.

**Your ECF awarded two grants totaling \$3,525.  
Donations to the endowment totaled \$4,904.50.  
Investment income received during  
the year was \$4,671.62.**

Your ECF was fortunate to receive a technical assistance grant of \$7,000 from the Ford Institute for Community Building. This grant was used for strategic planning to increase our organizational capacity. We are very pleased with the success of the Estacada Community Foundation's strategic planning and board building project. We currently have a Foundation with sound management, strong governance and an action plan that utilizes the Foundation's assets. Armed with a new mission, objectives, values and goals, board members are able to clearly communicate the purpose of the Foundation and how they will achieve its goals. We look forward to serving the needs of the Estacada community.

Many local residents have helped the Foundation grow by participating in the City of Estacada's "Add-on" program. This past year, we had thirty four residents and businesses participate with over \$1,400 directed to the Foundation in this campaign through their monthly water bills. If you are a city resident and not yet participating in this program the Foundation's Board of Directors invites you to consider this possibility.

Our number of corporate sponsors has increased and we look forward to more businesses helping to build the endowment. The Foundation also received its first remembrance fund as a memorial to long-time Estacada resident Simpson Dunlop. Mr. Dunlop was a pillar of the Estacada community and will be greatly missed.

The Board wishes to thank the community for their generosity and for supporting the work of the Foundation.

## GRANTS AWARDED

- ◆ **\$1950 Grant to the Estacada Library Renaissance Fair and Teen Scene summer workshops.** This grant and funds from other resources, enabled our local library to create and plan wonderful summer programs. This year's activities included a story festival to kick-off the summer's programs, a summer-long reading program for children, nine weeks each of a children's Thursday program and a Friday Teen Scene program (which included a portion on careers). The Renaissance Feast & Fair utilized 75 teen volunteers who assisted with creating, organizing and producing this delight for children and families who attended.
  
- ◆ **\$1575 Grant to the Estacada Family Resource Center (ECRF) remodel.** This grant and funds from other resources, enabled the ECRF to extensively remodel the Resource Center. The remodeling involved installing new carpet, a new ceiling, and new shelves. Operated completely by a volunteer staff, the Center serves as the food bank for Estacada and neighboring rural areas. The EFRC is the only source of emergency food supplies for the Estacada area and distributes approximately 100 tons of food each year.

**GRANTS RECEIVED**

- ◆ **\$7,000 Received from the Ford Institute for Community Building.** ECF received a technical assistance grant of \$7,000 from the Ford Institute for Community Building. This grant was used for strategic planning to increase our organizational capacity. ECF board members worked toward strengthening the foundations ability to support area programs and organizations.
